

# Protocol for Families and Dancers

Below are daily expectations of both families and dancers until further notice. If your dancer experiences any of the COVID-19 symptoms, please call the studio immediately so we can safeguard other dancers and the EDC team. ## Home Screening



- Complete the COVID-19 screening questionnaire for your dancer prior to arriving at the studio using EDC's Screening Questionnaire
- Mark your dancer's name on all belongings
- Pack nut free snacks
- Pack water to last the entire day (EDC will not refill water)
- Ensure your dancer has their mask and a paper bag for storing their mask
- Ensure your dancer has socks
- Ensure your dancer has proper footwear and clothing in their bag
- Have your dancer visit the washroom before leaving the house

If you have answered "yes" to any questions on the screening questionnaire, your child is not to attend dance and you are asked to call the studio immediately (number at top of page). Masking a fever or symptoms with medication is not tolerated

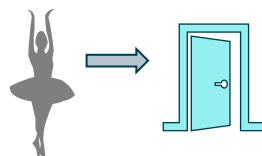
## Outdoor Screening



- Arrive at staggered times:
  - **Studio A - Back Door**
  - **Studio B - Front Door**
  - **Studio C - Front Door**
- Enter the parking lot and park at either the front or back parking lot of EDC
- Face mask must be worn by all individuals when being screened
- Wait outside studio door or in your car (for older dancers) for staff to greet your dancer
- Parents will not be permitted to enter the studio
- Each dancer's temperature will be taken by an infrared thermometer prior to entering the building
- Entry will not be permitted to anyone with a temperature over 37.8° C or who exhibit COVID-19 symptoms
  - If the COVID-19 screening questionnaire was not completed prior to arriving, we ask that you complete the questionnaire online from your vehicle.

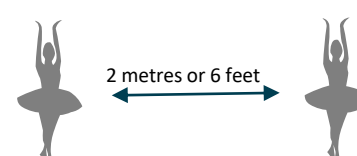
## Studio Entry



- Dancers who have passed the outdoor screening will be permitted to enter the studio
- They will be asked to use hand sanitizer at the station provided
- Dancers will place their shoes on designated shoe trays
- Dancers are to maintain physical distancing from their peers
- Acro dancers will be asked to sanitize their feet with an alcohol solution prior to dancing
- Those who come to the studio without socks will be asked to sanitize their feet with the alcohol solution at entry
- Once in the studio, dancers will place their personal belongings in a sanitized belongings bin
- Facemasks are to be worn until the dancer is in the studio where they will place their mask into a paper bag within the studio or in their belongings bin

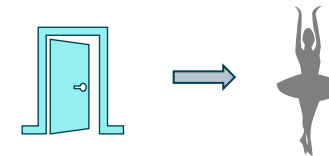
## In Studio



- Each studio has gridlines on the floor for safe physical distancing when dancing
- Health hygiene and frequent hand washing will be reinforced
- Dancers will be monitored for COVID-19 symptoms
- Close person-to-person contact will be kindly discouraged
- Sharing of food and water will be strictly prohibited
- One dancer will be able to go to the washroom at a time and are asked to walk on one side of the hallway and are encouraged to use hand sanitizers throughout the studio
- PPE will be worn by staff when interacting closely with dancers, when cleaning and in the event of a medical event

## Pick Up



- Pick-up at staggered times:
  - **Studio A - Back Door**
  - **Studio B - Front Door**
  - **Studio C - Front Door**
- Please be on time to pick up your dancers as they will be unable to wait in the studio
- Park at either the front or back parking lot and wait for your child to exit the studio
- If your child is younger, please exit your vehicle and proceed to the line-up area where you dropped off your dancer while wearing a facemask
- If you are exiting your car to wait for your dancer, you are asked to wear a facemask and stay near your vehicle maintaining physical distancing with other parents while waiting (for older dancers)
- Prior to exiting the studio, dancers will use hand sanitizer
- Parents and guardians are not permitted to enter the studio
